



# Initiatives to improve and promote Growth in the Alluvial Mining Sector: what we are doing

Improve or introduce Legislation for the alluvial gold mining sector in Papua New Guinea

Develop Alluvial Mining Code of Practice, Standards and Procedures to govern the Alluvial Mining Practices

Increased Small Scale Miners Training to Alluvial Mining Districts in PNG

Increase Alluvial Mining Licences to cover all Alluvial Mining Deposit areas throughout PNG

Increase Mechanised Alluvial Gold Mining Projects: increase production with improved safety and compliance practices

Set up Alluvial Mining Field Extension Program


Increase funding to Support Alluvial Gold Mining Sector of PNG




# Alluvial Gold Production & Revenue



